### 4. FIRST AID MEASURES

**INHALATION:** Remove to fresh air. Administer oxygen if needed. Apply artificial respiration if breathing has stopped. Get medical attention.

**EYE CONTACT:** Wash immediately with large volumes of fresh water for at least 15 minutes. Get medical attention.

### 5. FIRE FIGHTING MEASURES

**Suitable and unsuitable extinguishing media:** Foam, Alcohol foam, CO<sub>2</sub>, Dry chemical, Water fog. Water spray may be ineffective.

**Specific hazards arising from the chemical:** Closed containers may explode from internal pressure build-up when exposed to extreme heat and discharge contents. Liquid content of container will support combustion. Overexposure to decomposition products may cause a health hazard. Symptoms may not be readily apparent. Obtain medical attention. Hazardous decomposition products include carbon dioxide, carbon monoxide, and other

toxic fumes

**Special equipment and precautions for fire-fighters:** Water may be used to cool containers to prevent pressure build-up and explosion when exposed to extreme heat. Wear goggles and use self-contained breathing apparatus. If water is used, fog nozzles are preferred.
